"An Ordinance To Repeal And Recreate Sections 36-53 And 36-56 Of The Municipal Code Of The Village Of Rochester To Allow The Village Plan Commission To Grant Or Deny Conditional Use Permits In The Shoreland-Wetland And Shoreland Zoning Districts"

THE ORDINANCE HAS THE EFFECT OF ALLOWING THE PLAN COMMISSION FINAL APPROVAL/DENIAL AUTHORITY OF CONDITIONAL USE PERMIT APPLICATIONS IN THE SHORELAND-WETLAND AND SHORELAND ZONING DISTRICTS, AUTHORITY PREVIOUSLY HELD SOLELY BY THE VILLAGE BOARD:

SECTION 1. The proposed ordinance repeals and recreates section 36-53, subsections A and B, of the Rochester Municipal Code, and allows the Plan Commission to make final decisions on conditional use applications within the Shoreland-Wetland and Shoreland zoning districts.

SECTION 2. The proposed ordinance repeals and recreates section 36-56, subsections A, B, and C, of the Rochester Municipal Code, updating the procedural administration of conditional use permit applications involving the Shoreland-Wetland and Shoreland zoning districts. The procedural administration of these conditional use applications is updated to reflect the Plan Commission's processes and final approval authority.
